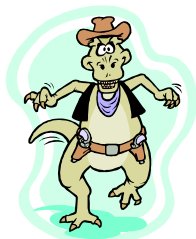

A cache of bizarre animal fossils unearthed in Australia includes killer kangaroos, marsupial lions, and a giant relative of a huge bird nicknamed the "demon duck of doom," scientists say.

Researchers from the University of New South Wales (UNSW) in Sydney say they found the remains of as many as 20 new species during a recent two-week dig in northeastern Queensland.

"There are weird, flesh-eating kangaroos," Michael Archer, science dean at UNSW, told Australian Broadcasting Corporation radio earlier this month.

"There are about 35 different kinds of extinct kangaroos in [Queensland] deposits. None of them would've looked like anything we would have recognized today, because they didn't hop," he said. "These were galloping kangaroos with big powerful forelimbs. Some of them had long canines like wolves." Henk Godthelp, a UNSW vertebrate paleontologist, says the new kangaroo discoveries include a saber-toothed species that may have used its large teeth for grooming or to attract mates.

"[The teeth] don't really look [like] anything used to rip intestines out of unsuspecting prey," he said. The team also found more complete skeletons of a previously known carnivorous kangaroo, an early species with short, muscular arms. "[It] looked like it would give you a very serious bear hug," Godthelp said, adding that 'roo may have used its arms to grab ambushed prey. "[It] used to leap out from behind trees and scare the bejesus out of prey and then calmly chomp it to pieces."

"Demon Duck of Doom"

The UNSW paleontologists also found fossils of a larger relative of a giant bird previously dubbed the "demon duck of doom."

Most closely related to modern ducks, the flightless "demon bird" probably resembled an enormous emu or ostrich, although fossil remains are scarce.

A single fossil leg bone from the new, larger find stands as high as his hip, Godthelp says. The bird's entire leg would have towered above his head.

"And I'm not a short chap. I'm well over six foot [two meters]," he said. "So these were big birds, and you can only imagine what some multinational like Kentucky Fried [Chicken] would have done with them."

Treasure Trove

The fossils come from the Riversleigh fossil beds in northeastern Queensland, an area rich in old river beds that later became riddled with limestone caves.

Acting like pit traps, the caves captured and preserved a wide array of plant and animal species from between 5 million and 20 to 23 million years ago and the environments they lived in.

Such a rich fossil record provides clues about how species evolved in response to climate change in ancient Australia, says Benjamin Kear, who studies ancient kangaroos at the Museum of Southern Australia in Adelaide.

Riversleigh digs have also uncovered fossils of Earth's oldest known kangaroos and many branches of the kangaroo family tree.

"The beauty of it is they're relatively complete skeletons as well," Kear said. "So you can start looking at things like how hopping evolved, which is quite a novel adaptation for a modern group of animals."

"It's one of the great things about Riversleigh," Godthelp added. "It actually allows us to collect many, many different kinds of things." Examples from recent years include a number of early crocodile species that were smaller than today's crocs and appear to have been land-based. It's been suggested that the ancient reptiles may have behaved more like modern-day goannas, or Australian monitor lizards.

The crocs may have climbed trees to escape predators and to leap on prey, scientists theorize.

It's difficult to deduce such behaviors from fossil records alone, however, Godthelp says.

The research team will prepare their new fossils and send them to researchers in Australia and elsewhere for further study.

ARTICLE I – Corporate Name

1. The name of this society shall be the Austin Central Texas Paleontological Society.

ARTICLE II - Registered Agent and Registered Office

1. The initial registered agent is an individual resident of the state whose name is set forth below

ARTICLE III - Management

1. Management of the affairs of the corporation is to be vested in its board of directors. The number of directors, which must be a minimum of three, that constitutes the initial board of directors and the names and addresses of the persons who are to serve as directors until the first annual meeting or until their successors are elected and qualified are set forth below.

ARTICLE IV – Organizational Structure

1. The corporation will have members

ARTICLE V – Duration

1. The period of duration is perpetual

ARTICLE VI – Purpose

The corporation is organized for the following purpose or purposes:

1. The purpose of the Austin Central Texas Paleontological Society is the scientific education of the public, the study and preservation of fossils and the fossil record and assistance to individuals, groups, and institutions interested in various aspects of paleontology.
2. Limitations: This organization is not created for profit but solely and exclusively for educational and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. None of its assets shall be used for the monetary gain or profit of the society or of any individual member.

ARTICLE VIII - Amendments

1. Approval to change the Articles shall be by a two-thirds majority vote of responding members at the monthly meeting after an announcement to the total membership.
2. A responding member shall be a voting member responding in writing or voting at the meeting.
3. Any proposed amendment to the Articles of Incorporation must be submitted to the Secretary of the Society in writing.
4. Any proposed changes in the Bylaws will be published in the newsletter at least twenty days prior to the meeting at which the amendment will be voted on.
5. Notification of amendments of Bylaws shall be included in the minutes of the meeting. Members will receive notice of any proposed changes in the Bylaws at least twenty days prior to the meeting at which the amendment will be voted on.

ARTICLE XI - Dissolution

1. In the event of the dissolution of this Society, assets of the Society shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal revenue Code, or corresponding section of any future federal tax code.

BYLAWS

Austin Central Texas Paleontological Association

A TEXAS NON-PROFIT ORGANIZATION

ARTICLE I - Membership, Dues and Fees

1. Requirement of membership is the payment of dues.
2. All members shall be of good character.
3. Honorary membership can be awarded by the recommendation of an active member and voted in by a majority present at the annual business meeting.
4. Dues amounts are established at the annual business meeting. Membership categories are 'individual', 'family' or 'associate'. Voting members consist of either adult individual or adult family members whose dues are current.
5. Associate members are non-voting and receive the newsletter, but are not otherwise active.
6. Dues shall become payable January 1st and shall become past-due on March 15th. Dues received after October 31 are credited to the following year.
7. All new members shall have available for review upon request a copy of the Articles and Bylaws
8. Dues paid by voting members shall include South Central Federation of Mineral Societies membership dues.
9. This Society shall be affiliated with and maintain an active membership in the Mid-America Paleontological Society.

ARTICLE II - Meetings

1. Monthly meetings shall be scheduled at a time and place as determined by the Board of Directors. A calendar of forthcoming meetings shall be published in the newsletter. Meeting minutes shall be published in the Newsletter and any changes or corrections shall be made at the next meeting.
2. To constitute a regular meeting, a member of the Board and a quorum of the membership must be present. A quorum for the regular meetings is defined as one-tenth of the voting membership.
3. The November meeting shall be the annual business meeting for the election of Officers, Board of Directors and honorary members.

ARTICLE III - Officers

1. Election of officers shall be held in November of each year with the new officers assuming their duties on January 1. Term of these officers shall be one year.

2. Officers shall be nominated for election by a nominating committee appointed by the President and/or by open nominations from the floor.
3. Officers shall be active members elected by a majority vote. No person shall hold more than one elected office at one time.
4. Vacancies shall be filled for the balance of the term by the Board of Directors.
5. Officers of this Society shall be: President, Vice-President, Secretary and Treasurer.
6. Vacancies shall be filled for the balance of the term of office by the Board of Directors.
7. President. The duties of the President shall be to preside over all meetings of the organization, appoint all committees deemed necessary, and see that the activities of the organization are designed to carry out the purpose of the Society.
8. Vice-President. The duties of the Vice-President shall be to perform the duties of the President in the President's absence. The Vice-President shall perform such other duties from time to time as may be assigned by the President or the Board of Directors.
9. Secretary. The duties of the Secretary are to keep and report the minutes of all meetings of the Society, and to maintain membership records and conduct correspondence as necessary, and to perform all duties incident to the office of the Secretary and such other duties from time to time as may be assigned by the President or the Board of Directors.
10. Treasurer. The Treasurer is charged with the custody of the Society's finances, and has authority to pay all bills recommended by the Board and approved by the membership and to report all information to the members. In general, perform all the duties incident to the office of the Treasurer and such other duties from time to time as may be assigned by the President or the Board of Directors. Treasurer is responsible for payment of Society's dues to the South Central Federation of Mineralogists by the 1st of January according to the Constitution and Bylaws of the SCFM, Article II, Dues Section 2 and 3.

ARTICLE IV – Board of Directors

1. The affairs of the corporation shall be managed by its Board of Directors.
2. Committee Chairmen, Society members or persons having business with the society may attend any meetings of the Board of Directors.
3. The Board of Directors shall consist of the President, Vice-President, Secretary, Treasurer, and three other active members elected to the Board at the annual business meeting.
4. The Board of Directors shall meet a least three times a year.
5. At the first monthly meeting following the election of a new Board they will present a proposed yearly budget to be voted on by the members.
6. Special meetings of the Board of Directors may be called by, or at the request of, the President or any two Directors.
7. Quorum - a majority of the Board of Directors shall constitute a quorum for the transaction of business at any meeting of the Board.
8. Minutes of the Board of Directors' meetings and actions taken shall be presented to the Society at the following meeting. The Society may accept or reject these minutes.
9. Informal Action by the Board of Directors - Any action required by law to be taken to the Board of Directors or any action which may be taken at a meeting of Directors, may be taken without a meeting, if consent in writing setting forth the action so taken, shall be signed by all the Directors.
10. In case of a Board vacancy in a given year, the Board of Directors shall appoint a new member to serve for the remainder of the year.

ARTICLE V - Compensation.

1. Directors and officers shall not receive any compensation for their services.

ARTICLE VI - Committees

1. There shall be standing committees appointed as needed by the Board of Directors.

ARTICLE VII - Authority

1. Robert's Rules of Order, Revised, shall govern this Society in all cases where applicable and in which they are not inconsistent with the Bylaws.

ARTICLE VIII - Fiscal Year

2. The fiscal year shall begin on January 1 and end on December 31 of each year.

ARTICLE IX - Amendments

1. Approval to change the bylaws shall be two-thirds of majority of responding members.
2. Responding member shall be a member responding in writing or voting at the meeting.
3. Members will receive notice of any proposed changes in the bylaws at least twenty (20) days prior to the meeting at which the amendment will be voted on. Notification of amendments of bylaws shall be included in the minutes of the meeting.

ARTICLE X - Waiver of Notice

1. Whenever any notice is required to be given under the provisions of the Texas Nonprofit Corporation Act, or under the provisions of the Articles of Incorporation or by the Bylaws of the corporation/organization, a waiver thereof in writing signed by the person or persons entitled to such notice, whether it be before or after the time stated therein, shall be deemed equal to the giving of such notice.

ARTICLE XI - Acceptance

1. Upon acceptance, these Bylaws shall become effective immediately.
